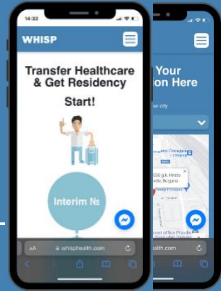

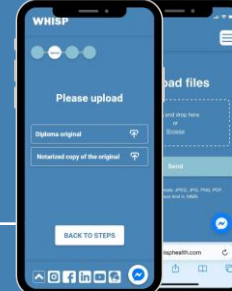

Summarized breakdown of the relocation process requirements to navigate you through bureaucratic requirements



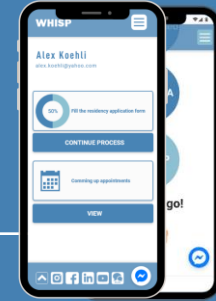
